WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$ 1,217,100.00 , Total Appropriations, including any Accumulated Deficit if any, of \$ 1,217,100.00 and Total Unrestricted Net Position utilized of \$0; and

WHEREAS, the Capital Budget as introduced reflects Total Capital Appropriations of \$639,000.00 and Total Unrestricted Net Position planned to be utilized as funding thereof, of \$639,000.00; and

Communications increase of \$500 or 11.1% due to increased costs

Video Lines increase of \$20,000 or 200% to reflect additional lines/mains maintenance

Machinery & Equipment Repair increase of \$10,000 or 20% anticipated increase in repair work

Plant Equipment increase of \$5,000 or 25% increased cost of equipment

Consulting Engineer increase of \$50,000 or 166.67% for capacity assurance report requirement

Purchase of Vehicle increase of \$12,000 for 1/3 portion of new pickup truck

The sewer minimum has not changed however the billing percentage of the water bill has decreased from 60% to 50%.

The local economy remains relatively stable. The proposed budget does not require any rate increases.
